

## **DEXUS STANDARD COMPETITION TERMS & CONDITIONS**

### **WILLOWS SHOPPING CENTRE / \$40,000.00 WILLOWS GIFT CARD GIVEAWAY Terms and Conditions**

1. These terms and conditions are for all entrants who enter the ‘\$40,000.00 Willows Gift Card Giveaway’ Promotion (“Promotion”). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The “Promoter” is Dexus Wholesale Property Limited (ABN: 47 006 036 442) as Responsible Entity for Dexus Wholesale Property Fund. The address is Willows Shopping Centre, 13 Hervey Range Road, Townsville, QLD 4817

#### **ELIGIBILITY**

3. Subject to condition, this Promotion is only open to Australian residents aged 18 years and over.
4. 11. All entries must be received between 9.00am to 5.30pm on Mondays, Tuesday, Wednesdays and Fridays; between 9.00am to 9.00pm on Thursdays; 9.00am to 4.00pm on Saturdays; or between 10.00am to 4:00pm on Sundays (AEST) to be eligible to be in the daily draw.
12. The promotional period may end earlier after the distribution of all 2,000 Willows \$20 Gift Cards.
