WILLOWS SHOPPING CENTRE / BUMBLEBEE FACEBOOK COMPETITION Terms and Conditions

1. These terms and conditions are for all entrants who enter the 'Bumblebee' Facebook Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.

ELIGIBILITY

GENERAL

21. Incomplete, indecipherable or illegible entries will be deemed invalid.
22. If there is a dispute as to the identity of the entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
