

DEXUS STANDARD COMPETITION TERMS & CONDITIONS

Willows Shopping Centre / \$500 Fashion Gift Card Giveaway Terms and Conditions

1. These terms and conditions are for all entrants who enter the ‘\$500 Fashion Gift Card Giveaway’ Centre Promotion (“Promotion”). Participation in this Promotion is deemed acceptance of these Terms and Conditions.

ELIGIBILITY
